*Public Act 97-256 amended the School Code by adding Section 10-20.47. – compensation report to 105 ILCS 5. On or before October 1st of each year, each school district in Illinois shall post on its internet website an itemized salary compensation report for every certified employee in the district working in a certified position. Additionally, Public Act 97-609 requires a compensation report for all IMRF employees whose total compensation package exceeds \$75,000 (5 ILCS 120/7.3). The compensation report shall include without limitation position, base salary, FTE, vacation days, sick days, bonuses, annuities, retirement enhancements, and any other form of compensation or income paid on behalf of the employee. This report shall be presented at a regular school board meeting, subject to applicable notice requirements and submitted to ISBE.
